Child Safeguarding Statement for Campa Cnoc an Dúin

This statement has been prepared in accordance with the requirements of the *Children First Act 2015*.

Statement

Lár-choiste Cúram and its members recognise and uphold the dignity and rights of all children, young people and vulnerable adults. They are committed to ensuring their protection, safety and well-being. Coláiste Curam will work in partnership with parents/carers and or guardians for them to achieve this. The organisation values and encourages the participation of children and young people in all activities that enhance their physical, emotional, intellectual, social and spiritual development recognising that each child is a gift from God.

Coláiste Curam is an Irish language summer college run by Cúram per the requirements of the Department of Education and Skills and the Children First Act 2015, Children First: National Guidance for the Protection and Welfare of Children 2017, the National Board for the Safeguarding of Children in the Catholic Church, and Tusla Guidance on the preparation of Child Safeguarding Statements, Coláiste Curam has agreed the Child Safeguarding Statement set out in this document.

- 1 The Principal Áine Ní Thuama has adopted and will implement fully and without modification the National Guidance for the Protection and Welfare of Children 2017.
- 2 The Designated Liaison Person (DLP) is Áine Ní Tuama, Príomh-oide
- 3 The Deputy Designated Liaison Person (Deputy DLP) is: Conchur O Muimhneacháin, Ball den Lár-choiste
- 4 Colaiste Curam recognises that child protection, and welfare considerations permeate all aspects of camp life and must be reflected in all of the camps policies, procedures, practices and activities. Coláiste Curam will adhere to the following principles of best practice in child protection and welfare as follows:
 - Recognise that the protection and welfare of children are of paramount importance, regardless of all other considerations.
 - Fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children.
 - Fully co-operate with the relevant statutory authorities about child protection and welfare matters.
 - Adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave them open to accusations of abuse. Develop a practice of openness with leaders.

- Fully respect confidentiality requirements in dealing with child protection matters.

5 The following procedures/measures are in place:

- Concerning any member of staff or leader who is the subject of any investigation (howsoever described) in respect of any act, omission or circumstance in respect of a child attending Knockadoon, the Coiste adheres to the relevant procedures set out in the National Guidance for the Protection and Welfare of Children and Vulnerable Adults.
- Concerning the selection or recruitment of staff and leaders and their suitability to work with children, the Coiste adheres to the statutory vetting requirements of the National Vetting Bureau (Children and Vulnerable Persons) Acts 2012 to 2016
- In relation to the provision of information and where necessary, instruction and training to staff in respect of the identification of the occurrence of harm (as defined in the 2015 Act) Coláiste Curam:
 - Provides each staff member and leader with a copy of Coláiste Curam Child Safeguarding Statement.
 - Requires all staff members and leader to avail of relevant child protection training every three years and or as new relevant training is required.
- All Coláiste Curam personnel must adhere to the procedures set out in Children First: The National Guidance for the Protection and Welfare of Children, 2017 in relation to reporting child protection concerns to the statutory authorities.
- Lár-Choiste Coláiste Curam has appointed the DLP named earlier as the 'relevant person', as defined in the Children First Act, 2015, to be the first point of contact in respect of the Camps Child Safeguarding Statement.

6 Coláiste Curam DLP, DDLP, and the Director of the Camp and Dominican brethren present on Camp are all Mandated Persons in accordance with the Children First Act, 2015.

7 Under the Children First Act, 2015, Coláiste Curam has assessed any potential for harm to a child while attending the Camp or participating in Camp activities. A written assessment setting out areas of risk identified and the Camps' procedures for managing those risks is in the Appendix..

8 The procedures referred to in this Statement are also posted in the public areas of the Camp.

- 9 The Child Safeguarding Statement is made available to all Coláiste Curam staff. A copy of the Statement is also made available to Tusla personnel if requested.
- 10 Coláiste Curam Child Safeguarding Statement will be reviewed annually or as soon as practicable after a material change in any matter to which this statement refers.

APPENDIX ONE

Risk Assessment Policy for Knockadoon Camp

The Dominican Friars of the Province of Ireland have carried out an assessment of the potential for harm to children, young people and vulnerable adults involved in Church activities in the Province. The following lists the identified risks and the practices and procedures in place for managing these risks:

Supervision ratios vary according to age and activities, for example 1/8 on outings and 1/10 on Camp.</p> <p>No camper is to be on the Pier or in the water unless a fully qualified Lifeguard is on duty.</p>

	<p>Campers are to be supervised at all times at the beach with the appropriate ratios of leaders to campers as referenced and additional leaders to supervise bathroom trips etc.</p>
<p>Administration of Medication</p>	<p>Medication is administered with the consent of parents/carers only and two leaders must always be present for the distribution of medication to children and young people.</p>

	<p>Parental permission is required for use of photography, video etc.</p> <p>Specific reporting procedures required for each group.</p> <p>Sign in book is required for every member on Camp during any one week.</p> <p>Daily check in and checkout system is essential.</p> <p>Visitor badges and sign in books is required for all groups using the Camp.</p> <p>All leaders must be Garda Vetted.</p> <p>All leaders must complete have the National Youth Council child protection training or equivalent and have read and signed the Knockadoon Camp Child Safeguarding Statement.</p>
<p>Any child, young person and or vulnerable adults may have been, is being or is at future risk of abuse or neglect which may go undetected and or unreported</p>	<p>Policy for Safeguarding Children, Dominicans Friars of the Province of Ireland, March 2010 has been circulated and continues to be provided to all church based ministries, parishes and services provided under the auspices of the Dominicans.</p> <p>Safeguarding information, training and advice provided by the Dominican Safeguarding Office and the NBSCCI. The DLP will provide advice, support and guidance to the Dominican brethren, staff, paid and unpaid, volunteers and students who have child protection concerns. This is done in accordance with Children First: <i>National Guidelines for the Protection and Welfare of Children (2017)</i>. If the DLP is not available the deputy DLP can be contacted on any child protection matter.</p> <p>Joint reports will be made by DLP/ deputy DLP and Mandated Persons, where appropriate taking account of data protection requirements.</p>
